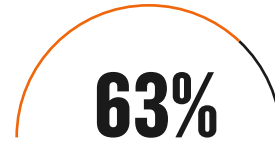
## THE CHALLENGE

As international supply chains become more complex, trade regulations more dynamic and outsourcing of logistics the norm, the knowledge a 3PL provides is critical to their clients.

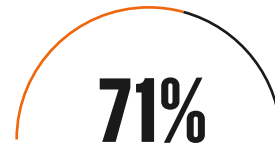
And with greater focus on customer service, 3PLs are looking for information tools for their sales and customer support teams that include greater shipment visibility and access to real-time data and analytics.

Resolving shipment inquiries and tracking freight quickly and accurately, bypassing laborious manual procedures customer service teams use today could offer opportunities for margin improvement.

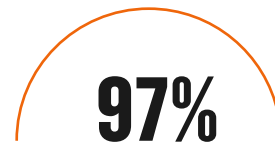

Locate shipments using booking, equipment, bill of lading and client reference numbers and be notified of changes to transport plans and shipping documents.

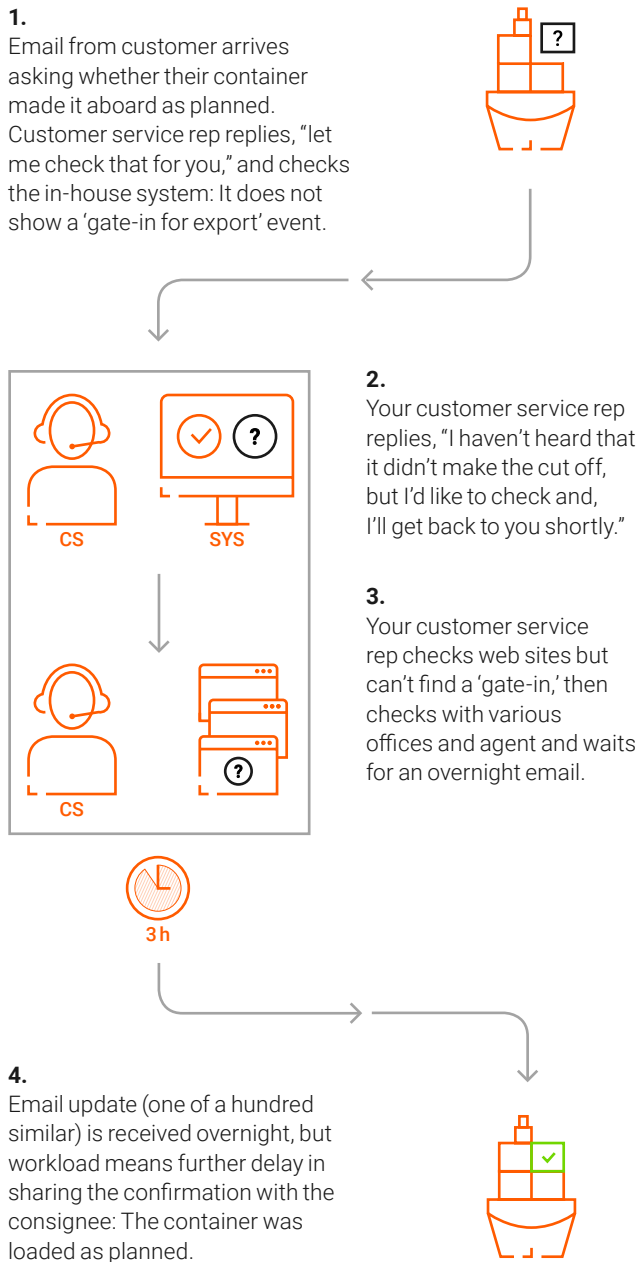

A consignee contacts you and asks whether their container made the departure cut off and is onboard the vessel.

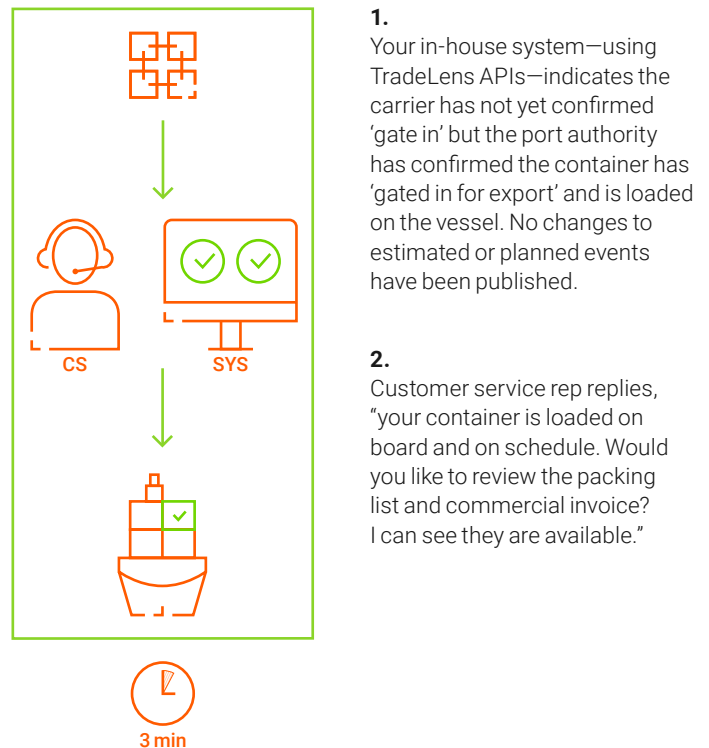

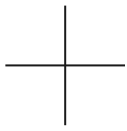

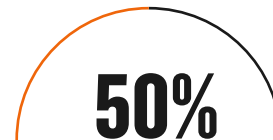

The logistics industry constantly strives to create operational processes that improve productivity and efficiency but must avoid replicating today's problems in a digital space.

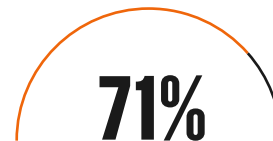
In a world where data is becoming the cornerstone of business, controlled, permissioned access to secure and immutable information is essential. Managing data without sophisticated software is hampering industry growth.

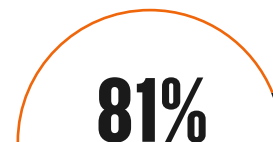

### Improve system integrations

Implement new clients that require data integration. Create multiple peer-to-peer EDI feeds that require reliability testing and continuous maintenance.

Use open-standard APIs with real time data transfer between supply chain participants via publish, subscribe, query and share functions. Or map and automate EDI feeds and other data formats from existing infrastructure to TradeLens.

# ENSURE SENSITIVE SHIPPING DOCUMENTS ARE SHARED ONLY WITH THE RIGHT PARTNERS

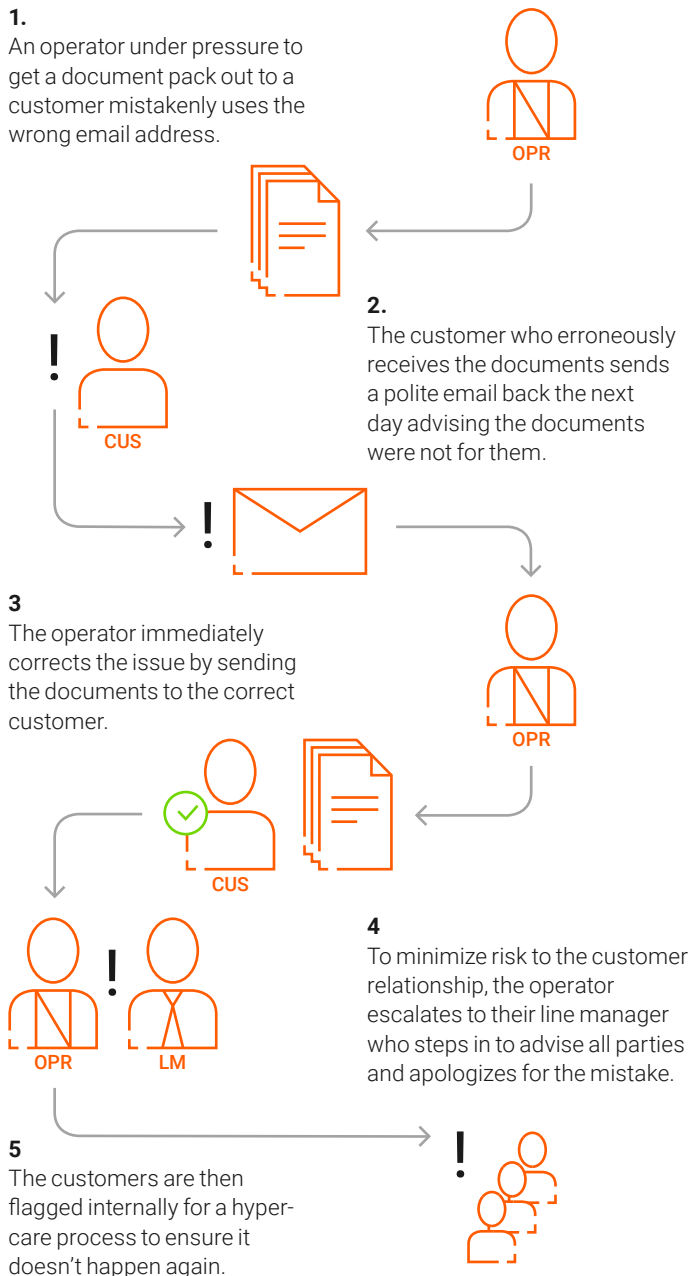

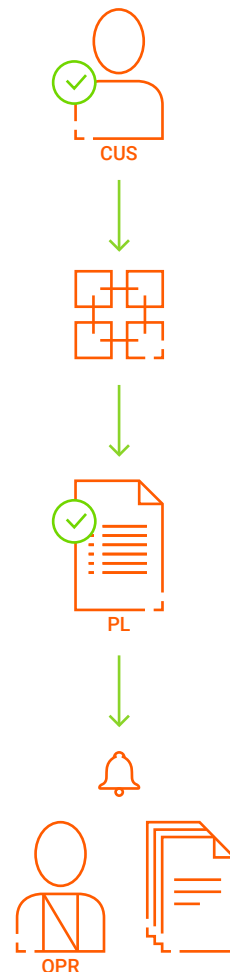

## THE CHALLENGE

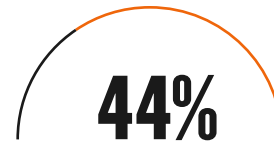

Facilitating the smooth movement of cargo shipments through customs and across international borders requires the coordination of numerous parties to shipments.

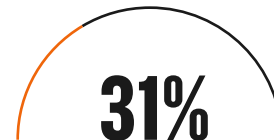
Delayed commercial paperwork can frustrate the job of expediting a quick and efficient clearance process. The variable IT systems and processes used by brokers' customers mean that document visibility is often limited and proactive measures are rarely possible.

## HOW TRADELENS CAN HELP



### Prepare clearance data sets

Gather and validate customs declaration data sets and verify supporting documents from multiple parties. Capture updates and prepare new data sets for customs clearance, potentially multiple times.

Access and use structured documents with rich data which can be readily searched for, found, analyzed and interpreted. Link data fields common to multiple structured documents to reduce keying errors and improve data quality.



### Clear consignments quickly

Expedite the customs clearance process in the most efficient way while maintaining compliance standards.

TradeLens gives you visibility over all of your shipments' events and flags document changes with a clear digital audit trail to simplify compliance management.



### Mitigate risks

Reduce the risk of handling forged or fraudulent documentation.

Rely on an advanced permissions model that controls who has access to publish and subscribe to data for any given consignment. Each time a document is edited or uploaded to the TradeLens platform, a new version of the document is added to the document store, identifying when and who has updated it.



### Maintain auditable documents

When handling multiple versions of documents and variable data sources, maintain a strict data and document management process for customer and compliance audits.

# OFFER GREATER RELIABILITY THROUGH THE CLEARANCE PROCESS USING DYNAMIC, STRUCTURED DATA

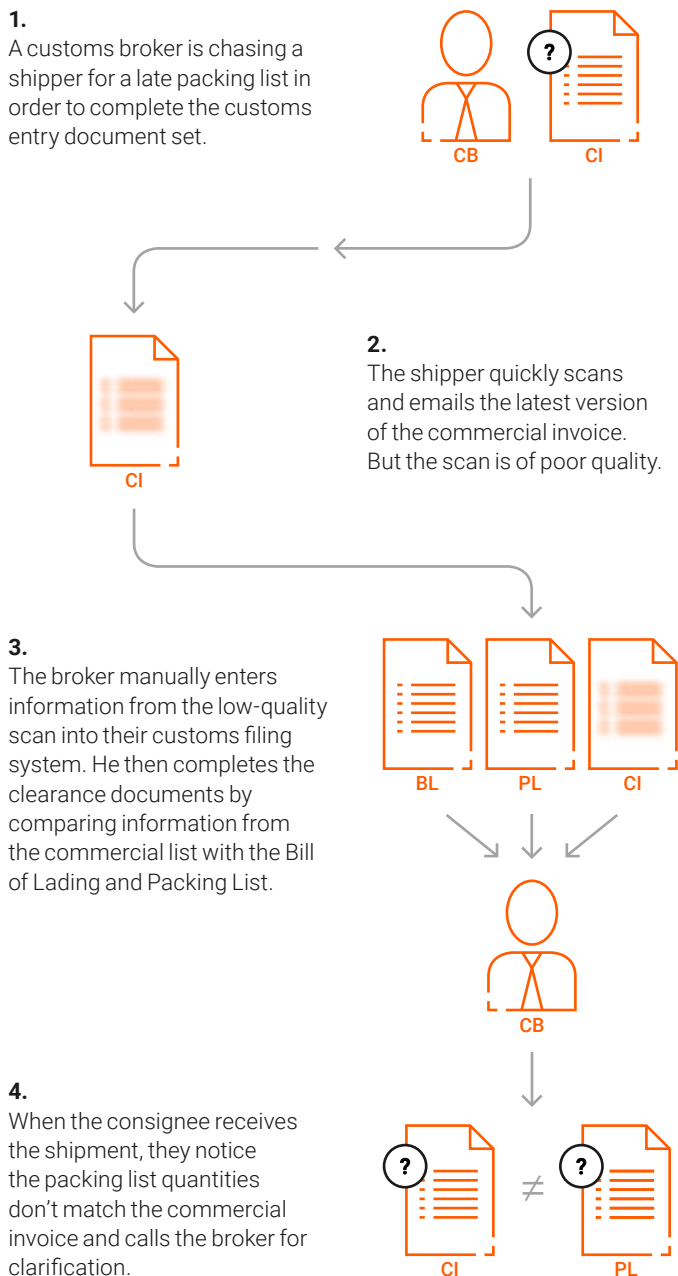
A customs broker is handling a customer's consignment and needs to access various documents in order to quickly complete a declaration filing.

Today, valuable data is locked in paper or unstructured documents that often needs to be re-keyed into a system for use.

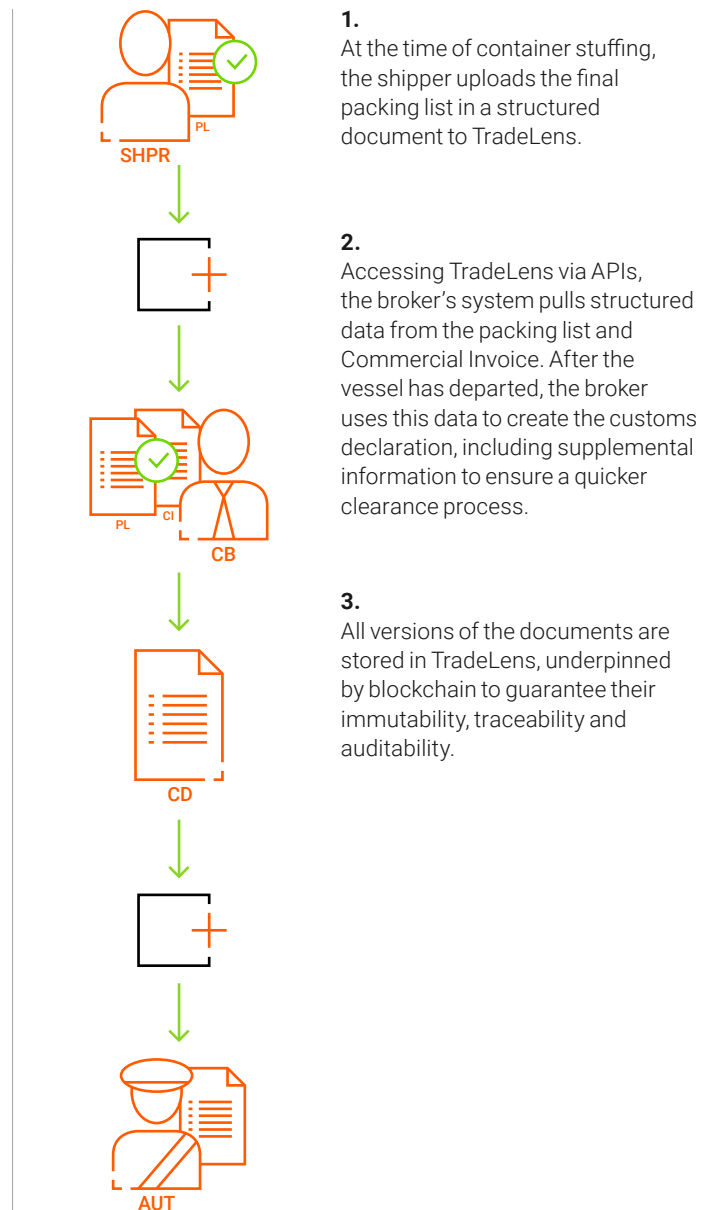

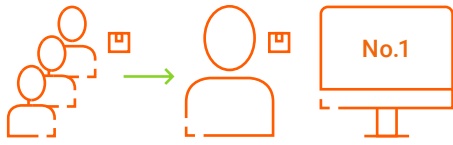

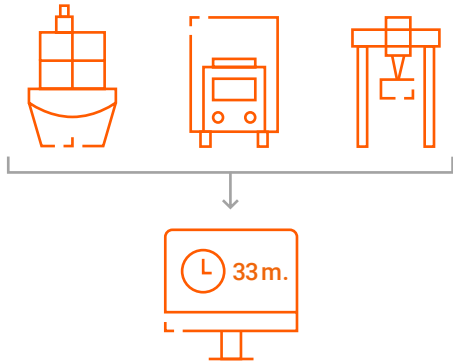

## IN PRACTICE



In a recent pilot, a 3PL using TradeLens found they were able to significantly improve their ability to effectively respond to the question, “Did the vessel leave yet?”, reducing their staffing from ten steps and five people to **one step and one person**.
